Product description

This ELISA kit applies to the in vitro quantitative determination of Neo-T4 concentrations in serum, plasma and other biological fluids.

Key Features

•Sensitivity: 0.94ng/mL.

•Detection range: 1.56-100ng/mL.

•Specificity: It can detect Neo-T4, in samples without obvious cross-reaction with other

analogs

•Repeatability: The coefficient of variation within and between plates is <10%.

Test Principle

This ELISA kit uses the Competitive-ELISA principle. The micro ELISA plate provided in this kit has been pre-coated with Rabbit Neo-T4. During the reaction, Rabbit Neo-T4 in the sample or standard competes with a fixed amount of Rabbit Neo-T4 on the solid phase supporter for sites on the Biotinylated Detection Ab specific to Rabbit Neo-T4. Excess conjugate and unbound sample or standard are washed away, and Avidin-Horseradish Peroxidase (HRP) conjugate are added to each micro plate well and incubated. Then a TMB substrate solution is added to each well. The enzyme-substrate reaction is terminated by the addition of stop solution and the color turns from blue to yellow. The optical density (OD) is measured spectrophotometrically at a wavelength of 450 nm ± 2 nm. The concentration of Rabbit Neo-T4 in tested samples can be calculated by comparing the OD of the samples to the standard curve.

Components and storage

Store the product at 2-8°C before unopened. Upon receipt, unpack promptly and store as recommended in the instructions.

Note:

Please ensure that the caps of all reagent bottles are tightened to prevent reagent evaporation and avoid microbial contamination.

The real volume will be slightly larger than the volume indicated on the label. Please use accurate measuring equipment instead of pouring directly.

Assay Procedures



Operation method

Precautions

- 1. Please wear protective equipment during the experiment. Please pay attention to biosafety protection according to the Biological Laboratory Safety Protection Regulations when contacting blood samples or other biological samples.
- 2. Kit components of different batches cannot be mixed (except Stop Solution).
- 3. The EP tubes and pipette tips used in the experiment are disposable, please do not mix them.
- 4. There may be a small amount of water-like substances in the wells of the newly opened ELISA plate. This is a normal phenomenon and will not affect the experimental results. Temporarily unused strips should be placed in a spare aluminum foil bag and stored

according to the required storage conditions.

- 5. Do not reuse the diluted standard, biotinylated antibody working solution, and enzyme conjugate working solution.
- 6. Unused Biotinylated Detection Ab Concentrate ($100\times$), HRP Conjugate Concentrate ($100\times$) and other original solutions should be stored according to the required storage conditions.
- 7. The ELISA reader needs to be equipped with a filter that can detect a wavelength of 450±10nm, and the detection range is between 0-3.5.

Materials required but not supplied

- 1. Microplate reader (450nm wavelength filter), Incubator capable of maintaining 37°C.
- 2. 1.5mL EP tube, absorbent paper.
- 3. Pipette and disposable tip: 0.5-10µL, 2-20µL, 20-200µL, 200-1000µL.
- 4. Double distilled water or deionized water.

Preparation

- **1. Equilibrate to room temperature:** Take the Elisa kit out of the refrigerator 20 minutes in advance and let it equilibrate to room temperature.
- **2. Preheat the microplate reader:** Please turn on the microplate reader at least 15 minutes in advance to stabilize the light source of the microplate reader during experiment.
- **3. Washing solution:** Dilute the Wash Buffer Concentrate (25×) with double distilled water (1:24).

Tip: The Wash Buffer Concentrate (25×) taken out of the refrigerator may have crystals, which is a normal phenomenon. You can use a 40°C water bath to slightly heat it to completely dissolve the crystals before preparing the washing solution. Use it on the same day.

4. Standard working solution:


- 4.1 Centrifuge the standard at 10000×g for 1 minute.
- 4.2 Add 1.0 mL of Reference Standard &Sample Diluent to the freeze-dried standard. After tightening the tube cap, let it stand for 10 minutes and invert it gently several times.
- 4.3 After the standard is completely dissolved, gently mix with a pipette to prepare a 100ng/mL standard working solution.
- 4.4 According to the experimental requirements, the standard is diluted in multiples. The recommended concentration gradient is: 100、50、25、12.5、6.25、3.13、1.57、0 ng/mL。 4.5 Multiple dilution method:

Prepare 7 EP tubes and add 500µL of Reference Standard & Sample Diluent to each tube. Pipette 500µL of the 100ng/mL standard working solution and add it to the first EP tube. Mix it with a pipette to prepare a 50 ng/mL standard working solution.

Next, take 500µL of the 50 ng/mL EP tube and add it to the second EP tube. Mix it with a pipette to prepare a 25 ng/mL standard working solution. And so on to obtain a standard working solution with multiple dilutions.

Note: The last tube is regarded as a blank. Just add the Reference **Standard & Sample Diluent**.

The illustration as below is for reference:



5. Biotinylated Detection Ab working solution:

Calculate the amount: Calculate based on the reagent requirement of 50µL/well, and add an additional 100-200µL in case of emergency.

Antibody dilution:

15 minutes before the experiment, use Biotinylated Detection Ab Diluent to dilute and mix **Biotinylated Detection Ab Concentrate (100×)** to 1× working concentration. The diluted antibody should be used on the same day to ensure the experimental effect.

6. HRP Conjugate working solution:

Calculate the amount: Calculate based on the reagent requirement of 100µL/well, and add an additional 100-200µL in case of emergency.

Antibody dilution:

15 minutes before the experiment, use HRP Conjugate Diluent to dilute and mix **HRP Conjugate Concentrate (100×)** to 1× working concentration. The diluted antibody should be used on the same day to ensure the experimental effect.

Operation Steps

1. Add Standard, Sample and Biotinylated Detection Ab working solution:

Add different concentrations of **Standard working solution** to the first two columns of ELISA plate wells from top to bottom, two wells for each concentration, 50µL per well; Add 50µL of the sample to each of remaining wells. High concentration samples need to be diluted first.

Immediately add 50 µL of Biotinylated Detection Ab working solution to each well.

Tips: During operation, solutions should be added to the bottom of the micro ELISA plate well, avoid touching the inside wall, shake gently to mix, avoid bubbles, and complete the sample addition operation within 10 minutes.

2. Cover the plate and incubate:

Cover the plate with the Plate Sealer provided in the kit. Incubate at 37°C for 45min.

3. Wash plate 1:

Remove and dry the liquid in the plate wells, add 350µL of **Washing solution** to each well, Soak for 1-2min, remove and dry the liquid in the plate wells, pat it dry against clean absorbent paper, and complete one wash.

Repeat this wash step 3 times. Dry the liquid in the plate wells for the next step.

4. Add HRP Conjugate working solution:

Add 100µL of **HRP Conjugate working solution** to each well. Gently shake to mix, cover the plate with a new **Plate Sealer**. Incubate at 37°C for 30min.

5. Wash plate 2:

Wash the plate 5 times, the steps are the same as step 3(Wash plate 1).

6. Add Substrate Reagent(TMB):

Add 90µL of **Substrate Reagent(TMB)** to each well. Cover the plate with a new **Plate Sealer**. Incubate at 37°C for about 15min, Protect the plate from light.

Tips: Adjust the incubation time according to the color change, but do not exceed 30 minutes. Once the standard wells show a clear gradient, the incubation can be stopped.

7. Stop the reaction:

Add 50µL of **Stop Solution** to each well to stop the reaction.

Tip: The order of adding Stop Solution should be as consistent as possible with the order of adding Substrate Reagent(TMB).

8. Measure the OD value:

Immediately measure the OD value (optical density) of each well of the ELISA plate with a micro-plate reader set to 450nm.

Calculation of results

1. Calculate the average OD value and draw a standard curve:

Calculate the average OD value of each set of standard duplicate wells.

Use the concentration as the x-axis and the OD value as the y-axis to draw the standard curve using the Logistic function.

2. Calculation of sample concentration:

Substitute the OD value measured by the sample into the curve to find the concentration corresponding to the sample OD value. If the sample has a dilution multiple, multiply the obtained concentration by the dilution multiple to obtain the sample original solution concentration.

3. Processing of high OD value samples:


If the OD of the sample surpasses the upper limit of the standard curve, the sample should be appropriately diluted and re-measured.

Technical Data

Typical Data:

The following data is for reference only. A standard curve must be run with each assay.

Precision:

Intra-assay precision (Precision within an assay): Low, mid range and high levels of the samples were tested 20 times on one plate, respectively.

Inter-assay Precision (Precision between assays): Low, mid range and high levels of the

samples were tested on 3 different plates, 20 replicates in each plate, respectively.

Recovery

5 different levels of target protein spiked in samples were evaluated for recovery experiments to determine the range of recovery and calculate the average recovery rate.

Linearity

5 different levels of target protein spiked in samples were evaluated for recovery experiments to determine the range of recovery and calculate the average recovery rate. Subsequently, the 5 samples were diluted to 2-fold, 4-fold, 8-fold, and 16-fold concentrations, and recovery experiments were performed again to evaluate the range and average recovery rate at different dilution factors.

Sample processing

Sample collection

- **1.Serum:** The whole blood sample is placed at room temperature for 2 hours or at 4°C overnight, centrifuge it at 1000×g for 20 min and collect the supernatant to carry out the assay. The tube used to collect blood should be a disposable endotoxin-free tube.
- **2.Plasma:** Collect plasma using EDTA-Na2 as an anticoagulant. Centrifuge samples for 15 min at 1000×g within 30 min of collection. Collect the supernatant to carry out the assay. Avoid using hemolyzed or hyperlipidemia samples.
- **3.Tissue homogenization:** Rinse the tissue with pre-cooled PBS (0.01M, pH=7.4) to remove residual blood, weigh and mince the tissue into small pieces. Add the minced tissue and the corresponding volume of PBS (generally, tissue weight (g): PBS (mL) volume=1:9, eg. adding 1g of tissue sample to 9mL of PBS, the specific ratio can be adjusted appropriately according to experimental needs. It is recommended to add protease inhibitors to PBS) into a glass homogenizer and grind thoroughly on ice. To further break down the cells, the homogenate can be ultrasonically broken or repeat freeze-thaw cycles. The homogenates are then centrifuged for 5-10 minutes at 5000×g, and collect the supernatant to carry out the assay.

4.Cell lysates:

Adherent cells: Gently wash with pre-cooled PBS, then digest with trypsin, and collect cells after centrifugation for 5 minutes at 1000×g.

Suspended cells: The cells can be collected directly by centrifugation.

The collected cells are washed 3 times with pre-cooled PBS. Add 150-200µL PBS to each 10⁶ cells, resuspend and break the cells by repeating freeze-thaw process (if the content is very low, the volume of PBS can be reduced). Centrifuge for 10 minutes at 1500×g and collect the supernatant to carry out the assay.

5.Cell culture supernatant or other biological fluids: Centrifuge samples for 20 min at 1000×g, remove impurities and cell debris. Collect the supernatant to carry out the assay.

Note for samples

1. Sample storage after collection:

Assay within 1 week: store at 2-8°C.

Assay within 1 month: please divide into single-use amounts and store at -20°C.

Assay within 3 months: please divide into single-use amounts and store at -80°C.

- **2.**Please predict the concentration before assaying. If the sample concentration is not within the range of the standard curve, it is recommended to conduct a preliminary experiment to determine the appropriate dilution ratio to ensure the accuracy of the results. (It is recommended to conduct a preliminary experiment after consulting the literature to determine the dilution multiple)
- **3.** If the sample type is not included in the manual, a preliminary experiment is suggested to verify the validity
- **4.**If a lysis buffer is used to prepare tissue homogenates or cell lysates, there is a possibility of causing a deviation due to the introduced chemical substance.
- **5.** Please be aware that some recombinant proteins may not be detected due to a mismatching with the coated antibody or detection antibody.
